UPI MAKING INDIA PROUD

In the last few years many of you might have experienced the ease of doing digital transactions. Nowadays its just a matter few seconds for sending and receiving money. So, most of you would be knowing the technology behind it i.e., Unified Payments Interface (UPI). Now you will be proud to know that India is the pioneer country in this technology.

What is Unified Payments Interface (UPI)?

It is an instant real-time payment system developed by National Payments Corporation of India (NPCI) facilitating inter-bank peer-to-peer (P2P) and person-to-merchant (P2M) transactions. The interface is regulated by the Reserve Bank of India (RBI) and works by instantly transferring funds between two bank accounts on a mobile platform.

How was it Developed?

In April 2009 with the objective to integrate all the payment mechanism available in the country and make it uniform for retail payments, National Payment Corporation of India was formed. By March 2011, RBI found out that in India only six non-cash transactions happen every year per individual citizen while 10 million retailers accept card-based payment.

Around 145 million families have no access to any form of banking. There is also the problem to tackle black money and corruption that happens mostly in cash.

RBI in 2012 released a vision statement for a period of four years that indicated commitment towards building a safe, efficient, accessible, inclusive, interoperable and authorized payment and settlement system in India. It is part of the Green Initiative to decrease the usage of paper in domestic payments market. UPI was officially launched in 2016 for public use.

Under RBI guidance, NPCI became the primary body with the task to develop a new payment system that is simple, secure and interoperable.

UPI Mechanism :

In simple words, UPI is an advanced version of IMPS and UPI ID/VPA can be considered as a unique email ID for the payments that are used by the banks to conduct the transaction using IMPS.

If a customer uses the IMPS services, the transaction would be done in a matter of a few seconds, but this also required the customer to enter banking details again and again which was a cumbersome task.





Also, the platforms provided by most of the banks (website or app) were not great. In short, UPI is a better avatar of IMPS.

In the process of a UPI transaction, the following entities are involved:

1. Payer app/PSP:

PSP stands for Payment service provider. Payer PSPs are apps that allow customers to initiate/complete transactions. For example: Gpay, Phonepe, Bhim, PayTM, etc.

These apps have replaced the traditional bank apps and allow users to create UPI handles to make or accept a transaction. Any customer can install these apps and can create their UPI handle. NPCI takes care of the app certification. However, all these UPI apps need a sponsor bank to start onboarding users. As of now these apps are not charging anything from their customers and are also not getting any significant amount from banks. Their focus as of now is on customer retention and data bank creation rather than earning commission.

2. National Payments Corporation of India (NPCI) :

NPCI is a non-profit org set up by RBI and funded by different major banks. It acts as a trusted switch to connect banks and Payment service providers (PSPs). Similar to the role played by VISA in case of Card payments, NPCI makes sure that data flow between banks and payment apps are routed to the correct and verified destinations.

NPCI, in the case of UPI payments, have made the banking services interoperable. Users can use any UPI app to link any of their bank accounts and can transfer or accept payments. NPCI also exposes a bunch of non-financial interoperable APIs for everyone in the ecosystem. For example: Validate VPA/UPI ID, Bank list, etc.

3. Issuing Bank (Sender's Bank) :

In case of UPI payment, the money is transferred from the issuing/sender's bank account to the acquiring (merchant/receiver's) bank account. Issuing bank has to debit money on NPCI's request and send a debit response to NPCI once the debit is successfully done.

4. Acquiring Bank (Receiver's bank) :

The acquiring (receiver) bank's job is to credit money on NPCI's request and send a credit response to NPCI once the credit is successfully done.

5. Payee PSP :

This is the acquirer or payment gateway used by the merchant in case of P2M (Person to Merchant) transactions.

SOME NUMBERS

From 93,000 transactions in August 2016 that valued ₹30 million, UPI generated 800 million transactions in March 2019 with a total value of ₹1.33 trillion. In June 2021, UPI recorded 1.94 million initial public offering (IPO) mandates that increased to 7.66 million in July. This is the highest ever since UPI was made mandatory by Securities and Exchange Board of India (SEBI) for domestic retail investors for IPO process. With 18 billion of annual transactions, UPI surpassed American Express (AmEx) by late August 2020 in India. NITI Aayog predicted that UPI will also surpass Visa and Mastercard by 2023. UPI took three years to reach 1.14 billion in October 2019 while by the end of October 2020, the payment system registered 2.07 billion transactions. In 2020, \$457 billion worth of value moved on UPI platform which was 15% of India's gross domestic product (GDP).





As of July 2021, UPI registered 432.5 million transactions that accounted for ₹567.345 billion with highest average daily transaction of approximately 100 million that is double the amount from July 2020. Till August 2021, UPI forms 10% of all retail payment in India. PhonePe and Google Pay both recorded 1 billion transaction in August with a market share of 45.94% and 34.45% respectively in the UPI payment ecosystem while Paytm took 11.94% share with ₹387.85 million transaction.

UPI IN THE GLOBAL SCENE

1. In December 2019, noting the success of UPI, Google suggested to the US Federal Reserve Board the development of FedNow, a real-time payment system for the United States.
2. With exponential growth of UPI, India became the world's largest real-time payment market with 25.5 billion annual transactions in 2020 as per data from ACI Worldwide and GlobalData leaving behind China and the United States.
3. Cross border digital payment service provider Liquid Group signed memorandum of understanding (MoU) with NIPL in September 2021 to introduce UPI based QR code payment system in Singapore, Malaysia, Thailand, Philippines, Vietnam, Cambodia, Hong Kong, Taiwan, South Korea, and Japan from 2022.
4. UPI is accepted at merchant locations to ease transaction experience of Indian tourists. The Reserve Bank of India (RBI) and Monetary Authority of Singapore (MAS) will operationalize interoperability between UPI and PayNow from July, 2022.
5. On 13 July 2021, UPI made available to Bhutan through Royal Monetary Authority of Bhutan.

UPI 2.0 – THE WAY AHEAD

1. On 16 August 2018, UPI 2.0 was launched which enabled users to link their Overdraft accounts to a UPI handle. Users were also able to pre-authorise transactions by issuing a mandate for specific merchant. 2.0 version included a feature to view and store the invoice for the transactions. There's also an added feature of AutoPay facility for recurring payments.
2. There is also provision for off-line UPI payment through the use of near field communication (NFC).
3. As per April 2021 RBI Monetary Policy Committee directive, after March 31, 2022, all the know you customer (KYC) compliant digital wallets will become interoperable by using UPI system.
4. It is likely to address some of the connectivity & technology problems.

BENEFITS

- Seamless fund collection from customers.
- Tap customers not having credit/debit cards.
- Digital transactions lead to better accounting.
- Resolves the COD collection problem.
- Single click 2 Factor Authentication facility to the customer.
- Round the clock availability.
- Single Application for accessing different bank accounts.
- Use of Virtual ID is more secure, no credential sharing.
- Raise Complaint from Mobile App directly.
- Increase in Financial Inclusion.
- Ease of doing business (Especially to small businessmen).





CHALLENGES :

1. Even though UPI transaction have boomed they are not able to eat up the share of physical cash transaction. In 2021 the Cash in circulation (CIC) to the GDP ratio is at record high of 14.5% which was 12% before demonetisation and immediately after that it dropped to 8%.
2. Even though UPI no. of transactions have exponentially increased the value of those transactions have not moved in that pace.
3. There has been increase in no. of transaction failure and delays which can be reduced by better server management.
4. Currently there is no Merchant Discount Rate(MDR) on UPI transactions and PSP are also not charging anything, which quite difficult to sustain. In future if they start charging then it may lead decline in no. of transactions.

CONCLUSION :

India has developed very unique and easy to use payment system which can challenge all the existing payment systems in the world. The usage of VPA and QR code in UPI is the essence. There are few challenges which needs to be addressed carefully in order to sustain UPI for mass usage.

2. *There Is A Cure For Worry*

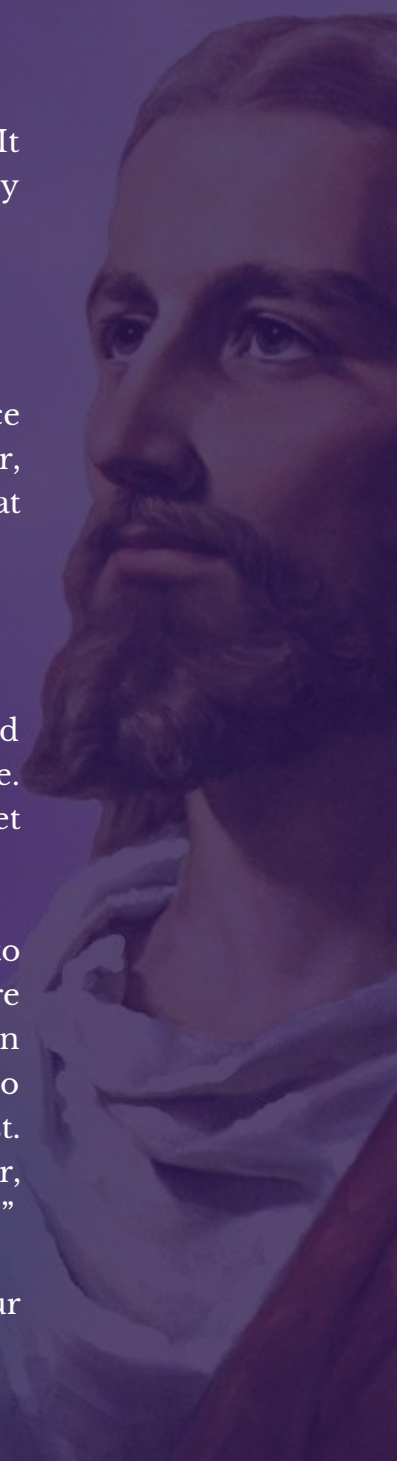

You’re familiar with the old written law, ‘Love your friend,’ and its unwritten companion, ‘Hate your enemy.’ I’m challenging that. I’m telling you to love your enemies. Let them bring out the best in you, not the worst. When someone gives you a hard time, respond with the energies of prayer, for then you are working out of your true selves, your God-created selves.”

When it comes to love we are given three directives: Love God. Love your neighbour. Love your enemies.





he first step forward to develop this love in your life is to learn to pray. But what is prayer? Simply handing over life's good and bad that we're handed to one far greater than ourselves – and that even includes our enemies. Seems back to front to conventional thinking – but I have seen many an enemy turned around 180 degrees through the power of simply praying that good happen in their life.

4. Follow The Golden Rule

“Here is a simple, rule-of-thumb guide for behaviour: Ask yourself what you want people to do for you, then grab the initiative and do it for them.” This is such a wonderful principle. Simply, do as you want to be done. Often the good turn won't come back from the one you did it for – but it will come back from somewhere in this amazing universe that we live in.

5. Ask For What You Need

“Here's what I'm saying: Ask and you'll get; Seek and you'll find; Knock and the door will open. Don't bargain with God. Be direct. Ask for what you need. This is not a cat-and-mouse, hide-and-seek game we're in.”

6. Judge Not

“Don't pick on people, jump on their failures, and criticize their faults—unless, of course, you want the same treatment. That critical spirit has a way of boomeranging. It's easy to see a smudge on your neighbour's face and be oblivious to the ugly sneer on your own. Do you have the nerve to say, ‘Let me wash your face for you,’ when your own face is distorted by contempt? It's this whole travelling road-show mentality all over again, playing a holier-than-thou part instead of just living your part. Wipe that ugly sneer off your own face, and you might be fit to offer a washcloth to your neighbour.” Point one finger in the direction of another in judgment and you have three pointing straight back at you. Not good. Resist the slippery slide towards judging others.

7. Keep Your Word

“Just say ‘yes’ and ‘no.’ When you manipulate words to get your own way, you go wrong.” If you can say yes. If you can't say no. Don't muck about by telling a lie when you know that you cannot do what you have promised. The word ‘no’ can be your most liberating friend if used wisely. You can't do everything, so start practicing the use of it. And if you say ‘yes’ ensure that you do what you say – even if it is inconvenient. This builds a depth of character in your being and trust from those around you.

CASE LAWS

THE LEGAL UPDATE

"M/S. N J DEVANI BUILDERS PVT LTD" VS. "UOI"

High Court of Delhi in this case held that petitioner had voluntarily registered under the head of 'commercial /industrial construction services', the petitioner is liable to pay service tax, is not tenable as the petitioner cannot be held to be liable to pay service tax before 01.06.2007, where, it is not in dispute that the petitioner was rendering 'works contract service', taxable only from 01.06.2007.

Comment: It is a settled law that the Principle of Estoppel does not apply to fiscal statute, which means the taxpayer is not bound by his previous act of assessment. In case anyone has adopted a wrong classification, the wrong rate of tax or wrong valuation, that can be corrected. The previous act which was incorrect shall not be binding on the taxpayer's present assessment.

The High Court of Kerala in case of Bon Cargos Pvt Ltd Vs Assistant State Tax Officer (INT) has held it is the duty of the transporter or the consignor, consignee to generate e-way bill when the aggregate value of the consignment is more than Rs.50,000/- and if otherwise ie., less than Rs.50,000/- there is no such requirement is not acceptable.

Relevant Provision:

- Rule 138(1) provides that every registered person who causes movement of goods of consignment having a value exceeding Rs.50,000/- in relation to supply has to generate an e-way bill.
- The proviso to Sub-rule 3 provides generation of the e-way bill at the option of registered person/transporter to general e-way bill when the value of the invoice is less than Rs.50,000/-
- Sub-Rule 7 provides the transporter to generate e-way bill, where the consignor/consignee has not generated an e-way bill where the aggregate of the consignor

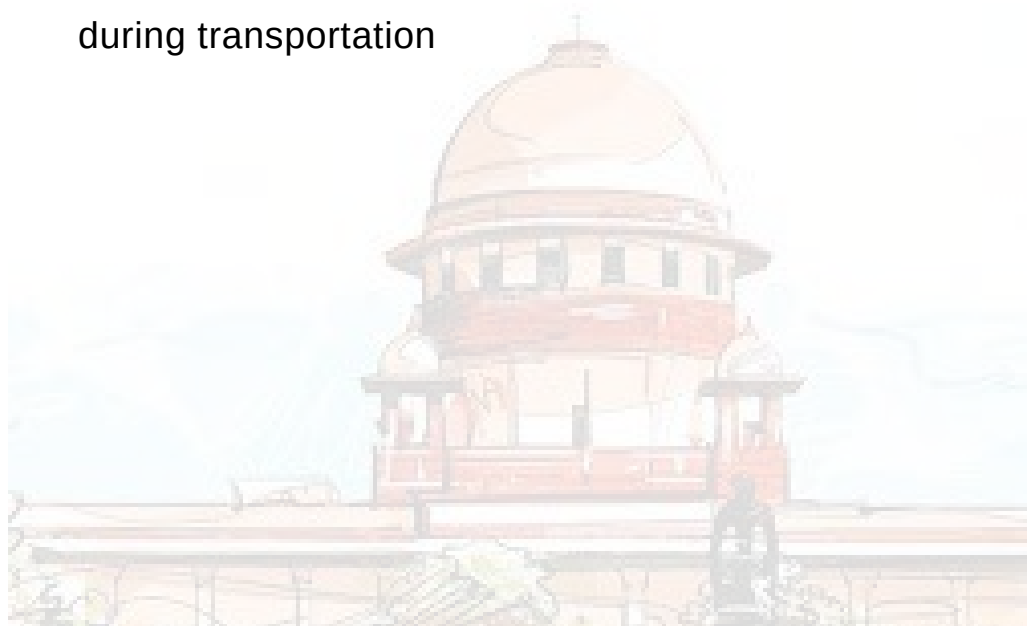
value of the goods carried in the conveyance is more than Rs.50,000/-

Comment :

In many cases, the consignment has been split to reduce each invoice value to less than Rs.50,000/- to avoid the generation of e-way bill. It is to be noted that the e-way bill is required when carried in the same conveyance even if the invoice value is less than 50,000 but exceed in aggregate.

Action Point :

It is recommended to generate the e-way bill irrespective of the value to avoid any disputes during transportation



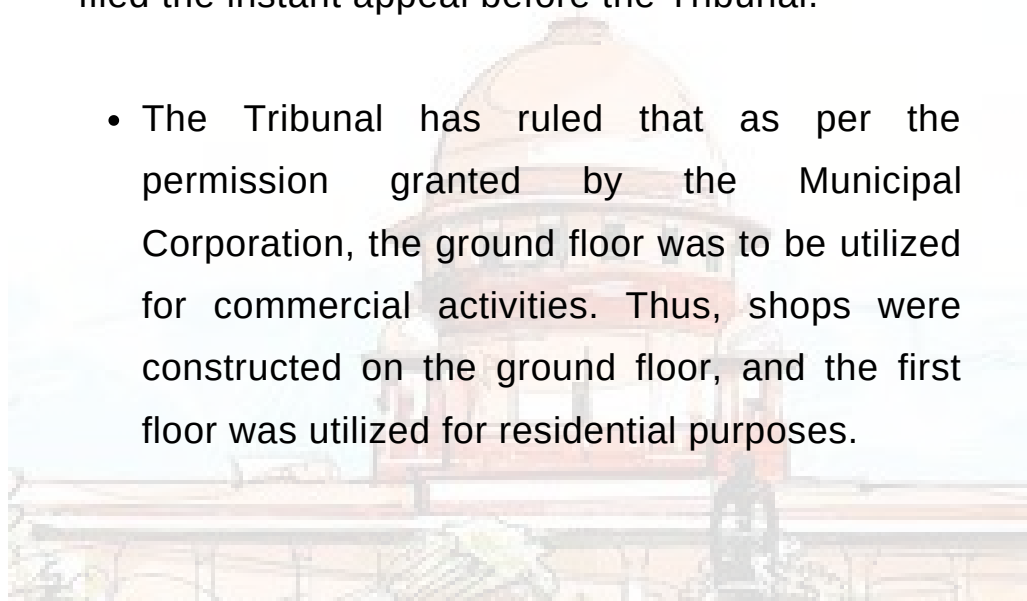


"ASHOK KUKREJA" VS. "INCOME- TAX OFFICER"

The assessee was an individual running the business of grinding of spices, wholesale trading of spices, Kirana items. During the assessment proceedings, the Assessing Officer (AO) observed that the assessee had claimed exemption under section 54F for purchasing house property located on the first floor of a complex having shops constructed on the ground floor.

The assessee claimed it to be residential property, but the AO considered it commercial, which cannot be used for residential purposes. Accordingly, the AO had denied the exemption and made additions to the income of the assessee. Assessee preferred appeal before the CIT(A) but couldn't succeed. He filed the instant appeal before the Tribunal.

- The Tribunal has ruled that as per the permission granted by the Municipal Corporation, the ground floor was to be utilized for commercial activities. Thus, shops were constructed on the ground floor, and the first floor was utilized for residential purposes.

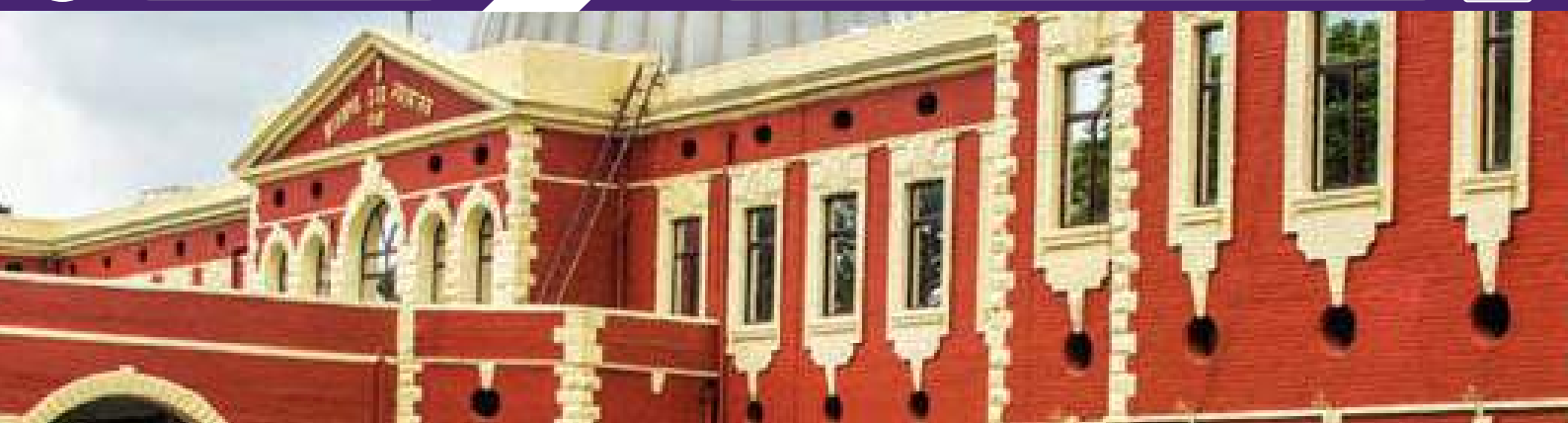




"ASHOK KUKREJA" VS. "INCOME- TAX OFFICER"

- The assessee had purchased the property as a residential property, and registering authority had also registered the said purchase after charging expenses valuing the said property for stamp duty value as a residential property. Municipal authorities have charged the property tax treating it as a residential property.
- It is noteworthy that Electricity Department had also considered the use of the said premises as residential use and had charged the electricity rates accordingly. The AO failed to place any contrary material to prove otherwise. Accordingly, the findings of CIT(A) were liable to be set aside.





CBDT ISSUES MORE CLARIFICATI- -ONS ON DEDUCTION AND COLLECTION OF TAX AT SOURCE UNDER SECTION 194Q.

TDS on the component of indirect taxes other than GST :

- Any buyer who is responsible for paying any sum to any resident seller for the purchase of any goods of the value or aggregate of such value exceeding Rs. Fifty lakhs in any previous year shall be liable for deduction of tax under Section 194Q.
- The CBDT vide Circular 13 of 2021, dated 30-06-2021, has clarified that in case GST component has been indicated separately in the invoice, tax is to be deducted under section 194Q only on the amount credited in account of seller without including GST. However, Circular 13 of 2021 is silent on other non-GST levies such as VAT, excise duty, CST, etc.
- Now, the CBDT has clarified that if the component of VAT, sales tax, excise duty, CST, etc., have been indicated separately in the invoice, then TDS under section 194Q is to be deducted without including such amounts.


