GST ON CARS

"Price Reduction on Cars, Festive Season just got **Brighter!**", "Price Reducti on – GST Benefits" Recently you might have seen all car manufacturers advertising the price drop in their cars after the introduction of "GST 2.0". But what changes were made? How does this impact the automobile sector? What were the GST rates earlier? Let's break it down. **Pre - GST Era: Before introduction of GST, Excise duty** was levied by Central Govt. on manufacturing and import of vehicles. Rates was slab based depending on the engine capacity and vehicle length and additional customs duty was imposed on imported cars. Value Added Tax (VAT) was levied by State Govt. on sale of vehicles which was in a range from 12.5% to 15% differing among the states. There were also other levies like Infra Cess, Road Tax, Registration charges etc. Earlier there was no uniformity in taxation and some states used to levy huge taxes whereas some states didn't, many exploited this and used to buy cars especially luxurious one's from states or UTs (eg. Puducherry) where taxes are low, as it resulted in savings in lakhs!

GST (till 21.09.2025):

showroom, approx.): ₹1,50,000 Registration + Insurance
(₹50.000): ₹50.000 On-Road Price: ≈ ₹23.75.000



GST 2.0 from 22.09.2025: On 3rd September, 2025, the 56th GST Council Meeting was held and major changes were made which also included simplifying tax rates for cars: reducing high effective tax burden, removing compensation cess, revising slabs and promoting festive consumption. The revised rates are applicable from 22.09.2025. Category Old Rates New rates "GST 2.0" Small Cars: length upto 4 meters and engine capacity of upto. 28% GST + cess 1% (petrol)/3% (Diesel) 18%, no compensation cess. Mid-Sized Cars 28% GST + cess 17%. Luxury cars 40%, no compensation cess. 28% GST + cess 20% SUV/MUV 40%, no compensation cess. 28% GST + cess 22% Electric vehicles 40%, no compensation cess. 5% GST (No cess) Customs duty on imported cars are still applicable. 5% GST (No cess) Let us now understand this with the help of example: Note: the price of vehicles mentioned in the example is based on assumption and not the original price quoted by the dealers.

GST 2.0 has also simplified the taxation on cars by eliminating compensation cess, and making unified rates of 18%/40% reducing tax burdens on consumers, therefore making cars more affordable, boosting automobile sector business, encouraging EV adoption. But the rate of 40% might still be high for a mid-size, luxury cars and SUVs compared to international standards, but overall removal of cess has eased the tax burden. Let's hope this reform turns out to benefit the citizens, encourage consumption and improve our economy in the long term.

Your role as a volunteer can also give you a sense of pride and identity. And the better you feel about yourself, the more likely you are to have a positive view of your life and future goals.




Fun and Fulfilment to your Life
